RELEASE AND HOLD HARMLESS AGREEMENT

The undersigned, being of lawful age, acknowledges there are great hazards, dangers and risks of injury or death associated with horses and horseback riding, including, but not limited to; the risk of falling from a horse or being thrown from a horse, striking an object while on a horse or being kicked by a horse, being bitten by a horse, trampled by a horse etc... I know that horses even under careful supervision are extremely unpredictable. Knowing and appreciating this danger, I desire to receive riding lessons, ride, participate in a clinic, ride on trails, lease or board a horse (or, as the case may be, have my child receive riding lessons, ride, participate in a clinic, lease or board a horse) with Jack and Paula Curtis LLC. Therefore, in consideration of the opportunity to ride and or be around horses at the farm of Jack and Paula Curtis LLC or elsewhere, to participate in equestrian activities, either there or **elsewhere**, and/or board/ or train a horse and for other good and valuable consideration, I do hereby:

RELEASE, Jack and Paula Curtis LLC, a Limited Liability Company, Paula Curtis & Jack Curtis, individually and as members and officers, their employees or agents, successors, and assign, and all other person, corporations, associations, or partnership-s and their insurers (hereinafter "Jack and Paula Curtis LLC") **FROM ANY AND ALL CLAIMS** whatsoever which I may hereafter incur on account of or in any way growing out of bodily and/or personal injury involving me or members of my family or guests and arising out of any horse related activities associated with Jack and Paula Curtis LLC.

I further COVENANT to never institute any suit or action against the above named for reason of any claim relating to such activities.

I shall INDEMNIFY and save Jack and Paula Curtis LLC harmless against any and all further claims and damages, costs or expenses which might result from any incident, accident, or injury to me, members of my family or guests, or any horses which may result from negligence of any of the above or third parties or any combination thereof.

I also agree and represent that I shall wear protective head gear with a chin strap at all times while mounted on a horse which head gear shall be acceptable to ASTM/SEI standards.

"NOTICE: Under Tennessee Law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Tennessee Code Annotated, title 44, chapter 20."
